- Cost Analysis to determine how much you should set aside for your pets
- Care Instructions that outlines how your pets should be cared for
- Backup Caregiver Program provided by Best Friends Animal Society


## Pet Trusts Created by Estate Planners

 While a pet trust may not be completely foolproof, pet trusts can be a good option. They typically cost $\$ 1000-\$ 2000$ to set up. An excellent resource is www.estateplanningforpets.org.
## Sanctuaries and Lifetime Care Programs

 for people who have no one that can serve as a potential caregiver, these programs can serve as good options but may not be able to provide the level of care your pets are accustomed to. We recommend that you inspect the program or facility to make sure it could be an environment where your pet will receive adequate love and care. ## COULD THIS HAPPEN? YOU BET!

This morning I woke up feeling great. Ran to the door and found my best friend waiting for me. We went for our usual morning walk. My friend does most of the talking, but I am happy just to be listening. My best friend's words are always soothing and comforting. After our walk, we went back home and had breakfast together. I got kissed on my nose and my best friend went off to work. Now comes my boring time. I walk around the house making sure everything is safe and secure, then I just lay on the couch or the bed or the easy chair waiting for my best friend to come home.

Today is different. Night has fallen. My friend normally is home by now. It is getting late. I'm starting to worry. I hope she gets home soon. I'm starting to get hungry. You know I don't care if I get to eat or not. I don't complain. Please come home. I miss you. I am so tired now. Why is it getting light out again? This is so strange. I need to get on the bed. I can smell my friend was here. This is where I feel safe. Wait! I hear someone at the door-it must be her, No, it is someone I don't know. Who are you? Why are you coming in here? Are you going to hurt me? Rob my friend's home? What am I supposed to do? I know. I will act mean. I will growl, bark, defend my friend's home the best that I can. They have just put a leash on me. They are trying to talk calmly to me, but I don't trust them. I will still act mean. I just heard them say my friends name and something about a fatal heart attack. Now I am in a small cement barred area. This is not the food I normally eat. These are not the smells I normally smell. I am so scared. I still need to act mean. I know my friend must be trying to find me. I have been here for about a week now. I hear people talking about me being aggressive. Wait. They are opening my door. They are putting that leash on me again. My friend must be here. Now I am in the exam room. Oh I see the needle again. My friend always told me the needles will help keep me healthy. I felt the pinch-this needle is different. Something is happening. I feel very sleepy...where is my friend?

We know how much you care about your beloved pets. Please make sure this does not happen to your friends.

## ADOPT AN ORPHANED PET DAY

On the eve of remembrance of the tragedy of 9-11, 2nd Chance 4 Pets launched a national campaign this to promote adopting orphaned pets from shelters. Adopt an Orphaned Pet Day was launched this past September to help to create awareness and reduce the numbers of companion animals needlessly euthanized throughout the US each year.

Adopt an Orphaned Pet Day has been established in tribute to the 800 pets that were orphaned on 9-11 in New York City when their human companions whose average age was 39 years old tragically died. Fortunately, animal rescue groups across the country joined forces to find new homes for these pets. Unfortunately, there are not enough resources to currently help find homes for all 500,000 pets that become orphaned each year when their owners die.

Pet owners predecease their pets due to natural and man-made tragedies- hurricanes, fires, floods, car accidents and even terrorism. Unfortunately, there are 500,000 reasons for pet owners to plan for the lifetime care of their pets while they are able to make such important decisions.
"Most responsible pet owners are not aware of the planning options that are available to ensure continuous care for their pets", says Amy Shever, Director of 2nd Chance 4 Pets. "Our organization is helping pet owners plan for the lifetime care of their pets by assisting them with establishing emergency plans, and encouraging them to select other caregivers who are committed to caring for their pets."
"575 dogs and cats were put to death in US shelters every hour last year," says Cyrus Mejia, artist and creator of The Best Friends Animal Society Art Project, a memorial to these pets. "Since many of these animals are healthy and adoptable the efforts of 2nd Chance 4 Pets have tremendous potential to significantly reduce these numbers. It will guarantee life for pets that have provided constant love and companionship."

In California alone, animal control agencies and shelters euthanize an estimated 750,000 to 1 million dogs and cats annually to deal with the surplus of companion animals. This method of animal control costs California taxpayers in excess of $\$ 50$ million annually (Assembly Bill 2513). Spay and neuter programs represent the most successful organized prevention strategy to reduce the number of pets relinquished to animal shelters each year. These programs have reduced unwanted breeding and population, but the numbers of pets still being euthanized throughout the country is still at epidemic levels.
"The tragedy of 9-11 forced many of us to realize that we need to plan ahead for the care of all aspects of our lives - including our pets," explains Jane Hoffman, President of the Mayor's Alliance for NYC's Animals. "We are encouraging pet owners to make sure that should anything happen, their pets are cared for. The lives of thousands of animals will be saved, and pet owners will benefit from peace of mind knowing that they have planned for the lifetime care of their pets."

## COMPONENTS OF A LIFETIME CARE PLAN

Our pets do so much for us, yet few of us have done anything to ensure the long-term care for our pets. Having a lifetime care plan for your pets will provide peace of mind by insuring that the animals you love have the kind of life you want to give them - even if you're not around to provide care.

## A comprehensive care plan includes:

CAREGIVERS - Identify people who could step in to take care of your pets temporarily, in the hours, days, or weeks after an emergency, or who would adopt your pets should you die or become incapacitated. If you cannot find friends, relatives, or neighbors to care for your pets, your veterinarian, local pet sitters and animal rescue groups may be able to help you locate potential caregivers.

INSTRUCTIONS - How do you want your pets to live - in another household or in a sanctuary? What kind of special care do your pets require? Do you want your pets to stay together? To make sure that your wishes are followed, your instructions must be written down and someone must know where to find them.

FINANCING - You pay for food, shelter, supplies and medical care for your pets. Those expenses won't stop if you aren't here to pay them. You may want to set aside funds for temporary or foster care, transportation to a new home and the ongoing care for your pets.

## PET INSURANCE, PEACE OF MIND

Not so long ago, it was the inherent usefulness of animals that made them an important part of people's lives; the animals performed a specific task, and it was relatively easy to calculate their value accordingly. Today, by contrast, $81 \%$ of U.S. pet owners view their animals as family, or even children. How do you put a price on the well-being of a family member?
More than $60 \%$ of U.S. households own at least one dog or cat; many others have birds and more exotic companions. Every year, pet owners in this country spend more than $\$ 11$ billion on medical services for these animals. With veterinary costs on the rise (one estimate puts the increase at $30 \%$ per year), there is growing interest in finding ways to ensure optimal medical care for pets without bankrupting their owners.
Another important factor in the discussion is the ever-increasing breadth of medical services available for animals. Cancer treatment, pacemakers, bone grafts, organ transplants, joint replacements, MRIs and CAT scans, ultrasound testing, endoscopy, urine and blood analysis-these procedures are no longer just for humans. People who are willing to invest the necessary time and money can find a qualified veterinary specialist to treat virtually any ailment their pet may develop.
Proactive planning for major veterinary expenses is something every responsible pet owner should be concerned with. With no plan in place, the heartbreaking choice is all too often "financial euthanasia." Pet insurance is one way to ensure that a beloved pet is never denied critically needed treatment due to lack of financial resources.
Pet insurance is basically indemnity coverage that is designed to take care of unforeseen events. In the U.S., it falls under the property and casualty requirements of state insurance departments; the insurance company that underwrites the policy must be licensed and admitted in a given state in order to do business, and the policy must be filed and approved by each state insurance department.
These stringent regulatory guidelines help explain why only $1 \%$ of pet owners in the U.S. insure their pets, as compared to $19 \%$ in England and 49\% in Sweden; there simply are not many companies that offer pet insurance in this country. The three main providers that compete on a national level are Veterinary Pet Insurance (VPI) at http://www.
petinsurance.com/, 800-872-7387); Hartville Group, provider of Petshealth Care Plans at www.petshealthlan.com, 800-807-6724; and Pethealth Inc. at http://www.pethealthinc.com/, 877-738-4584. Pet insurance are also available through Premier Pet Insurance at http://www.ppins.com/, 877-774-2273.
Policies and premiums vary, depending on factors such as age, size, and breed of pet; geographic location; previous illnesses and preexisting medical conditions; claims experience; and plan type selected. Costs range from approximately $\$ 100$ to $\$ 450$ annually per pet, with deductibles, co-payments, and unreimbursed costs paid by the policyholder. Some packages are comprehensive, including annual checkups and vaccinations, routine care, preventive medications, and spay/neuter surgeries; other plans cover only accident and illness. Annual deductibles average around $\$ 100$.
Not everyone is a fan of pet insurance. Consumer Reports, for example, maintains that pet owners are better off establishing a savings account to handle pet health emergencies. On the other hand, many veterinarians encourage their clients to take advantage of pet insurance to help ensure consistent and high-quality medical care.
The nature of your relationship with your pet will help form your decision. Ask yourself: "Do I want a pet, or do I want this pet?" If you're the type of person who would devote unlimited time and money to healing your special companion animal, then you are a good candidate for pet insurance.
If you decide to invest in pet insurance, experts recommend shopping around and carefully evaluating the different packages that are offered. It's also wise to discuss the benefit schedules with your veterinarian, to determine to what extent the benefits will cover the actual cost of various treatment options. In any case, a carefully chosen plan can give the pet owner peace of mind that the pet will receive the best medical care regardless of cost.
Owners may also consider alternatives to pet insurance. Besides a dedicated savings account, options include various discount pet care savings programs like Pet Assure http://www.petassure.com/pa/index.asp and United Pet Care http://www.unitedpetcare.com/, and prepaid packages such as that offered by the Banfield hospital network http://www.vetsmart.com/. Pet Assure, for
example, gives club members a $25 \%$ across-the-board discount on in-network veterinary care, plus price breaks on a variety of petrelated services and products.
In addition to preparing for extraordinary medical expenses, there are many ways to save on routine veterinary costs. Here are some things to consider:

- Conduct price comparisons, getting estimates from several different veterinarians.
- If your pet has a serious problem, be sure to get a second opinion before consenting to costly tests and treatments.
- If your pet needs medication, check to see if it's available at a regular pharmacy, where it will usually be less expensive. Also, buy frequently used medicine in bulk and request generic drugs when possible.
- Get booster shots every three years instead of annually, if possible.
- Ask your veterinarian about discounts on annual exams, especially if you take multiple pets to the same office.
- In choosing a pet, keep in mind that some breeds are predisposed to genetic disorders.
- Check prices for shots and spay/neuter services at your local humane society; some also provide free or low-cost services to low-income and senior pet owners.
- Research pet disorders and consult a good pet healthcare reference; the detailed Merck Veterinary Manual is free online at www.merckvetmanual.com/mvm/index.jsp.
- Examine your pet regularly for lumps, bumps, and skin irritations; regular bathing and grooming helps prevent many skin irritations and reduces the chance of infection.
- Be proactive about preventive care and nutrition.
So, should you take the plunge and buy insurance on your pet? As noted above, the most important thing to keep in mind is that (1) you may be faced with large and unexpected veterinary bills at some point, and (2) if you love your pet, you won't want a life-or-death decision to hinge on the ready availability of significant financial resources. Pet insurance is one way to ensure that the best care will always be available for the pets that enrich your life.
